Each "renewal date" is considered a new agreement (a new contract), to which you are committed to paying in its full amount.

I UNDERSTAND that under the terms of this agreement, the instructor(s) of Mind-Body-Spirit Martial Arts Corp are obligated to furnish to me with competent instruction and suitable facilities for teaching lessons. Qualified personnel trained in the traditions and procedures of the martial-arts supervise all classes. The regular hourly tuition is \$125.00 per hour, however a substantial discount has been provided to me by virtue of enrolling in a regular course. *This contract does not include any testing fees, or cost of sparring equipment.* **This agreement is non-transferable.** We will *not* be held responsible for any student participating in our free community outreach program; it is strictly voluntary, and is held outside the classroom...in the community. This program requires a legal guardian/parent to be present with any student who is under 18 years old.

THE STUDENT hereby represents that he/she is physically fit to receive and participate in the prescribed course of instruction.

I UNDERSTAND and agree that Grand Master Perceval and all **Mind-Body-Spirit Martial Arts Corp instructors** will not be held liable for injuries, damages, etc...not caused by or resulting from the negligence of the owners, operators, employees, or person in charge of such establishment or in the course of business. I also fully understand the martial arts is a full contact sport and therefore assume all risks involved.

I WILL faithfully comply with all the rules and regulations of **Mind-Body-Spirit Martial Arts** instruction and instructors and such persons running the establishment and the traditions of the martial arts. I also understand that failure to complete lessons does not relieve me of my obligation to pay my tuition in full. A student can attend classes only in the amount they pay for, which is based on their membership "**Program.**"

THE UNDERSIGNED AGREES to receive and participate in martial arts lessons, and Mind-Body-Spirit MA instructor(s) agrees to teach a course of martial arts lessons consisting of [2] lessons per week during a period starting / / .

I ACKNOWLEDGE receiving a copy of this agreement.

AS REQUIRED by general law, you have certain rights to cancel this agreement. You may cancel this agreement without penalty of further obligation **within** three (3) working days from the date of this agreement. If you become disabled or injured during membership, and that disability is confirmed in writing by a physician, you have a right to an extension and or termination of the contract. If you move your residence more than 25 miles from the facility, your membership may be cancelled within 30 days written notice in advance, in writing. Notice of any cancellation of membership must be sent certified mail to: 2912 Bayview, Avenue, Baldwin NY 11510. After 3 working days, **you are committed to the full-amount due on this contract unless** the above conditions of cancellation are met. Each month is considered a "payment period." At the start of this payment period, you are obligated to pay the full amount for that month's period without any exceptions. If paying by credit card, you are required to sign a "credit card authorization form" giving us permission to charge your card on file for monthly payments due at time of contract renewal, stated under "Renewal date" on this agreement. Agreements that are longer than one month require a down payment of at least one month's tuition which is non-refundable. If a student wants to go on vacation, a "Student Vacation" form must be signed 30 days in advance of your vacation. In the case of an illness, an "Illness Interruption" form must be signed, and a doctor's note *is* required. If a student becomes injured or disabled and can not attend class, the student & or account holder must fill out an "Injury/disabled Interruption" form and provide a doctor's note.

PAYMENTS must be made in full and on time before student may attend any classes.

I UNDERSTAND my rights as stated above.
